CIRCULAR

In continuation of the earlier Circular dated 21.03.2020, the Courts in South Goa District shall undertake only remand work and very urgent matters including anticipatory bail applications, bail applications, injunctions, stay, etc. from 30th March 2020 till 15th April 2020, between 11.00 a.m. to 1.00 p.m., on all working days with minimum staff members, i.e. one Clerk and one Peon only.

For registration, the Superintendent/Head Clerk together with one Clerk and one Peon shall attend the Office on all working days, from 30^{th} March 2020 till 15^{th} April, 2020, between 11.00 a.m. to 1.00 p.m.

The following arrangement is made for the Judicial Officers who work in the District Court and all Taluka Courts.

1. At the District Court, Margao, the following Judicial Officers shall attend remand work at the District level and utmost urgent cases, if any, between 11.00 a.m. to 1.00 p.m., on the respective dates:

30th March 2020 & 6th April 2020

2. At Civil Court, Margao, the following Judicial Officers shall attend remand work and utmost urgent cases, if any, between 11.00 a.m. to 1.00 p.m., on the respective dates:

3. At Civil Court, Vasco, the following Judicial Officers shall attend remand work and utmost urgent cases, if any, between 11.00 a.m. to 1.00 p.m. on the respective dates:

30th March 2020 to
1st April 2020 - Ms. Vijayalaxmi R. Shivolkar
3rd and 4th April 2020 - Ms. Apurva R. Nagvenkar
6th to 8th April 2020 - Ms Vaishalli Ashok Lotlikar
13th & 15th April 2020 - Ms. Purva Vishnudas Naik
However, regular remand work should be attended
by the regular Remand Judge.

4. At Civil Court, Quepem, the following Judicial Officers shall attend remand work and utmost urgent cases, if any, between 11.00 a.m. to 1.00 p.m. on the respective dates:

30th March to 5th April 2020 and

13th to 15th April 2020 - Ms. Aruna P. Fernandes 6th April to 12th April 2020 - Ms. Nilima S. Kankonkar.

- At Civil Courts in Sanguem and Canacona, Judicial Officers shall attend remand work on all working days, holidays and Sundays.
- 6. The Judicial Officers nominated on the respective dates for remand and urgent work shall be considered as Remand Judges for the whole day allotted to them.

The respective Judge at Taluka places shall prepare the list of the staff members who are residing nearby and furnish their names/addresses and vehicle number to the Office of Collector, South Goa, Margao, for issuing passes. Accordingly, the CAO/Superintendent incharge shall furnish such list of the staff attending District Court to the Collector, South Goa, Margao for issuing passes from 30th March 2020 till 15th of April, 2020.

Only one Clerk and one Peon of the above Judicial Officers shall attend the Court for the above period. In case of urgency and in instructions of the Principal District Judge, the Judicial Officer and concerned staff shall attend the Office, as and when directed.

Only on Monday, 30th March 2020, the Bench Clerk/Incharge of each Court working in South Goa shall attend the Office at 11.00 a.m. in order to upload the future dates from 30th March 2020 till 15th April 2020, excluding holidays and Sundays.

The concerned Judicial Officers are directed to instruct Bench Clerks/Incharge to upload/give dates of the matters of their respective Courts in the following manner:

- (a) All the matters which are below five years old and where there is no urgency shall be posted in June 2020.
- (b) All matters which are above five years old shall be posted from 20th April 2020 onwards by taking

precaution that the oldest matter shall be kept commencing from the week of 20^{th} April 2020.

- (c) The matters which are kept for orders, judgments, final hearings and the matters which are at the fag end, shall be posted from 16th April 2020 onwards.
- (d) After uploading dates in CIS System, as directed above, the Administrative Judge of each Taluka Court shall intimate about it to the concerned Advocates Association and one notice to that effect shall be pasted outside Court premises.
- (e) All mediation matters, pre-litigation matters, Lok Adalats, camps under the Scheme of NALSA shall be adjourned/postponed and the same shall be fixed after 16th of April 2020, as per the convenience and instructions of the Chairperson of Taluka Legal Services Committee. The Mediators shall be intimated accordingly.

(f) The Secretary DLSA shall co-ordinate with the Taluka Chairpersons, Mediators and upload such dates on the website of District Court.
